This booklet is designed to heighten awareness of the absence of racial discourse and Afro-Brazilian journalists from Brazilian television.

Araújo dos Anjos, Rafael Sanzio. Territórios das Comunidades Remanescentes de Antigos Quilombos no Brasil. Brasília: Edição do Autor, 1999. (1 copy)

This report compiles information about Afro-Brazilian and quilombo history and presents a general perspective on the African Diaspora in Latin American but specifically in Brazil.

Arruti, José Maurício. Mocambo: Antropologia e História do processo de formação quilombola. São Paulo: EDUSC, 2006. (1 copy – book is also available at the Benson Collection)

Arruti wrote this book as Ph.D thesis in anthropology. It chronicles a case study of the Mocambo community and how legal processes aided in its process of consolidation and land titling.

This book is a compilation of photojournalism conducted in the quilombos of Brazil. It provides some contextual information and maps to understand where the photos originated. Work was conducted in collaboration between academics, activists and the Brazilian government's Secretaria especial de políticas de promoção da igualdade racial da Presidencia da Republica.

The authors of this newsletter are responsible for various publications making quilombolos aware of their rights. This particular publication conveys the organization's successes in working with quilombos for their land rights.

The Comissão published this booklet in order to make quilombo residents aware of their rights and of the steps involved in the collective land titling process. The publication includes copies of key legislation.

Coordenadoria Ecumênica de Serviço. *Racismo no Brasil: Por que um programa com Quilombos?* Salvador da Bahia: CESE, 2003. (1 copy)

This publication is the result of a study conducted on Afro-Brazilians in a cooperative effort by EED (Igrejas Evangélicas na Alemanha) and CESE (Coordenadoria Ecumênica de Serviço). The project systematized information regarding the demographics and socio-economics of Afro-Brazilians and created a coalition, PAMN, to pursue further initiatives.

Da Silva, Maria Nilza e Jairo Queiroz Pacheco. *O negro na universidade: o direito a inclusão.* Brasília: Fundação Cultural Palmares, 2007. (2 copies)

Da Silva and Pacheco study the public university system in Brazil, analyzing the low levels of inclusion of Afro-Brazilians in higher education. As they make clear, all Brazilians contribute tax dollars into the educational system, but only 2% of public university students are black.

Do Sul, Helena. *Rota Existencial.* Brasília: Fundação Cultural Palmares, 2007. (2 copies)

Do Sul's book is a compilation of Afro-Brazilian literature, both contemporary and historical. It is used in research as a volume of social anthropology of the Afro-Brazilian community.

Fundação Instituto de Terras do Estado de São Paulo – ITESP. *Acesso à terra, regularização fundiária, promoção do desenvolvimento, fortalecimento da cidadania.* São Paulo: ITESP, 2007. (2 copies)

This thin brochure presents the goals and activities of ITESP in 2007, including background on the Foundation's achievements since 1995.

Fundação Instituto de Terras do Estado de São Paulo – ITESP. *Fatos da terra: Pontal do Paranapanema Ano 6 No 19 (2007).* (2 copies)

The primary function of this magazine is to relate information about the agrarian reform movement, definitions and applications of social function and the importance of the civic participation of the small landholder.

Fundação Instituto de Terras do Estado de São Paulo – ITESP. *Programa Cadastro de Terras e Regularização Fundiária: Vale do Ribeira.* São Paulo: ITESP, 2003. (1 copy)

ITESP explains its program to register and title rural lands using GPS technologies and displays maps of measured territories.

Informative brochure with basic information about quilombo communities, including a map with the locations of quilombos.

Gricoli Iokoi, Zilda Marcia. *Vozes da Terra: Historias de vida dos assentados rurais de Sao Paulo*. São Paulo: Fundação ITESP, 2005. (1 copy)

This book, published with the support of social organizations and the Brazilian government recounts oral histories from quilombo settlements in the rural areas surrounding Sao Paulo. Limited statistical information regarding quilombo inhabitants is also included.

Movie set in the historical context of Afro-Brazilian life prior to the 1960's in the community of Pituba, Brazil.

Instituto Nacional de Colonização e Reforma Agraria. *Revista de Direito Agrario Ano 1 no 1 (2º trimestre de 1973)*. Brasília: Incra, 2007. (3 copies)

Collection of articles and publication of legislation all focused on agrarian reform and titling processes in Brazil. Several articles speak directly about quilombo land claims and conflicts.

Instituto Pro Bono. *Responsabilidade Social no Direito*. São Paulo: Instituto Pro Bono, 2007. (3 copies)

This pamphlet, published by the Instituto Pro Bono in São Paulo, is a recruiting document for English and Portuguese speakers to work with underprivileged communities, including women and Afro-descendants.

The Instituto Socioambiental has published this commemorative publication to update the public's understanding of all of their environmental initiatives. These initiatives are conducted in coordination primarily with indigenous groups.

The Fala Egbé newsletter presents basic information from the Projeto Egbé program that conducted case studies in quilombo communities around Brazil. They report their findings from Candomblé in brief, with particular attention paid to the problem of formalizing land rights.

The Fundação Cultural Palmares has created this booklet with the authorship of Mauricio Pestana to explain affirmative action initiatives in a careful, cartoonist fashion. The publication is clearly designed to be easily accessible to a wide audience.

Pinheiro do Andrade, Inaldete. *A calunga e o maracatu*. Recife: Prefeitura, Secretaria de Cultura, 2007. (2 copies)

Pinheiro's writing presents literature about Afro-Brazilians and references to the African Diaspora in a conscious attempt to contribute to the strength of African identity in Afro-Brazilian movements.

Plataforma DhESC Brasil. *Recomendações do Comitê de Direitos Econômicos, Sociais e Culturais (DESC) ao Estado Brasileiro*. Brasília: Passo Fundo, 2005. (1 copy)

This report, authored by the Committee for Economic, Social and Cultural Rights, analyzes each of these three areas and makes policy suggestions based on each of their findings. The report is not specifically directed at Afro-Brazilians, but it does take into account their concerns.

Ramos, Maria Augusta, Directora. *Panfleto de resenha Juízo*. Brasília: Diler & Associados, 2007. (1 copy)

Publicity for the movie Juízo with reviews of the movie and analysis related to the Brazilian justice system and the treatment of Afro-Brazilians within the system.

Santos Junior, Waldomiro. *A Grade Refazenda: Africa e Diaspora Pos II CIAD/The Great Revival: Africa and Diaspora Post-CIAD II*. Brasília: Fundação Cultural Palmares, 2007. (2 copies)

This brochure is part of the Agenda Social Quilombola and its projects to improve access to land and land titling.

Secretaria Especial de Políticas de Promoção da Igualdade Racial. Política Nacional de Saúde Integral da População Negra. Brasília: SEPPIR, 2007. (2 copies)

This report publishes the findings of a study of the public health of Afro-Brazilians conducted by the Ministério da Saúde. Additionally, the report concludes with policy suggestions for the corresponding government agencies at the local, state and national levels.

Secretaria Especial de Políticas de Promoção da Igualdade Racial. Programa Brasil Quilombola. Brasília: SEPPIR, 2005. (2 copies)

SEPPIR has published this guide to the “Programa Brasil Quilombola” which is designed to facilitate the process by which quilombo communities are able to incorporate as associations. It outlines the legal framework for incorporation and suggestions for how this process might be useful politically.
