You are required to certify that you will have at least \$25,000 available (\$40,000 for the Graduate School of Business and \$30,000 for the School of Law) for your first-year expenses at the University of Texas at Austin, exclusive of travel expenses (This is based on 2003 estimates. For more information see http://www.utexas.edu/international/issis/students/new). Estimates include tuition and fees for fall and spring semester and 12 months living expenses. They do not include summer tuition. The cost of tuition is determined by the legislature of the State of Texas and is subject to change without notice. You should also indicate how you will meet your expenses for subsequent years of study. When computing your expenses, remember that students should not look to employment as a means of support unless an offer of an academic appointment (teaching or research assistantship) accompanies admission to a graduate department. Financial aid is generally not available to new international students, and financial assistance to continuing students is extremely limited.

If you are a married applicant who plans to bring your spouse and/or child(ren), you must certify the availability of at least an additional \$5,670 per year for your spouse and \$2,268 for each child. The spouse of an F-1 student visa holder is not permitted to work; the spouse of a J-1 exchange visitor visa may apply for permission to work upon arrival in the U.S.

Students enrolled at the University are required to have health and accident insurance, which is included in the cost of tuition and fees. It is advisable for all dependents to have health and accident insurance. Dependents of J-1 exchange visitors are required to have health and accident insurance which could cost an additional \$1763 (spouse); \$945 per child per year.
