May 25–27	Tuesday–Thursday Add/drop for the summer session for students who have registered and paid their fees.	July 9	Friday Registration for students enrolling for second term only; to complete registration, fees must be paid no later than 5:00 PM.
May 29	Saturday Summer residence halls open at 9:00 AM.	July 12	Monday Classes begin for second-term courses.
May 31	Monday Memorial Day holiday.	July 13	Tuesday Last day of the official add/drop period for the second term; after this date, changes in registration require the approval of the department chair and usually the student's dean. (See <i>General Information</i> , chapter 4, for required approvals.)
June 1	Tuesday University Health Services benefits become available to all students.	July 15	Thursday Fourth class day for second-term courses; this is the date the official enrollment count is taken. Last day an undergraduate student may add a second-term course except for rare and extenuating circumstances. Payment for added courses (add bill) due. Last day to drop a second-term course for a possible refund. (See <i>General Information</i> , chapter 4, for required approvals.) Last day a graduate student may, with the required approvals, add a second-term course.
June 1–2	Tuesday–Wednesday Registration for the summer session. Students who register on June 1–2 will register for all courses to be taken during the summer session; to complete registration, fees must be paid no later than 5:00 PM on June 2.	July 16	Friday Last day to apply for an undergraduate degree. Last day an undergraduate student or a law student may register in absentia. Last day to register for the fall semester during the summer session for new summer session students and continuing and readmitted students.
June 3	Thursday First-term, nine-week, and whole-session classes begin.	July 23	Friday Last day to drop a second-term course without a possible academic penalty. (See <i>General Information</i> , chapter 4, for required approvals.)
June 4	Friday Last day of the official add/drop period for first-term, nine-week, and whole-session courses; after this date, changes in registration require the approval of the department chair and usually the student's dean. (See <i>General Information</i> , chapter 4, for required approvals.)	July 27	Tuesday Last class day for nine-week courses.
June 8	Tuesday Fourth class day for first-term, nine-week, and whole-session courses; this is the date the official enrollment count is taken. Last day an undergraduate student may add a first-term, nine-week, or whole-session course except for rare and extenuating circumstances. Payment for added courses (add bill) due. Last day to drop a first-term, nine-week, or whole-session course for a possible refund. (See <i>General Information</i> , chapter 4, for required approvals.) Last day a graduate student may, with the required approvals, add a first-term, nine-week, or whole-session course.	July 28–29	Wednesday–Thursday Final examinations for nine-week courses other than law courses.
June 10	Thursday Last day to apply for a graduate degree. Registration begins for the fall semester for new summer session students who have paid their fees for summer, and for continuing and readmitted students who have not yet registered for fall.	July 28	Wednesday Reading day for nine-week law courses.
June 16	Wednesday Last day to drop a first-term, nine-week, or whole-session course without a possible academic penalty. (See <i>General Information</i> , chapter 4, for required approvals.)	July 29–30	Thursday–Friday Final examinations for nine-week law courses.
June 23	Wednesday Last day a student may change registration in a first-term, nine-week, or whole-session course to or from the pass/fail or credit/no credit basis.	July 30	Friday Last day a student may change registration in a second-term course to or from the pass/fail or credit/no credit basis.
June 30	Wednesday Last class day for first-term two-hour law courses.	August 6	Friday Last class day for second-term two-hour law courses.
July 1	Thursday Reading day for first-term two-hour law courses.	August 9	Monday Final examinations for second-term two-hour law courses.
July 2	Friday Final examinations for first-term two-hour law courses.	August 13	Friday Last class day for second-term and whole-session courses, including three- and four-hour law courses. Last day to submit master's report, recital, thesis, doctoral dissertation, or treatise to the graduate dean. Last day to drop a second-term or whole-session course. (See <i>General Information</i> , chapter 4, for required approvals.)
July 7	Wednesday Last class day for first-term courses, including three-hour law courses. Last day to drop a first-term course. (See <i>General Information</i> , chapter 4, for required approvals.)	August 14, 16	Saturday, Monday Final examinations for second-term and whole-session courses, including three- and four-hour law courses.
July 8–9	Thursday–Friday Final examinations for first-term courses, including three-hour law courses. No classes for nine-week and whole-session courses.	August 16	Monday Official graduation date. (No public exercises.)
		August 17	Tuesday Summer residence halls close at 9:00 AM.
